Dear Pastors, Deacons, SAMs, lay leaders, members, and friends of the Northwest Synod of Wisconsin.

Happy New Year! Did you make a New Year's resolution? I wonder what would happen if entire congregations or even if the whole church council would make a New Year's resolution together. What would it be? What might be a God pleasing, faithful New Year's resolution for you, personally? Your church? Your church council?

What is your congregation's New Year's Resolution?

Maybe the New Year's resolution might be to begin every church meeting in the next year by asking a God question like, "I wonder, what does God want us to accomplish in this meeting today? How might what we do in our meeting today

PASTOR'S REPORT – 2022

Grace to you and peace from God our Father and our Lord Jesus Christ.

What a pleasure it is to be writing this annual report as your pastor. Only a few short weeks ago, you called me to your service, welcomed me with open arms, minds, and hearts, and powerfully reminded me of God's presence in all we say and do. I am delighted to have inherited a congregation with a big heart. My predecessor Pastor Sue, as well as your interims Pastor Nancy and Pastor Andrea, were diligent in supporting you both personally and as a congregation reaching out to others in love.

We have challenges to address in the next years: an aging building, a need for vision, open communication, marketing and relevance in the community, and an understanding of our place in what God is already doing in this location. Your willingness, however, to be open to new ways of thinking about ministry and identity as children of God and siblings with Christ is an outstanding asset. Your faithfulness in generosity, attention to detail in practical matters, and willingness to experiment will positively impact our life as a community. We have much to do and to learn, but we will do it together and with hearts tuned to Christ. We are literally located on a hill, and I know we can be—and are already—the city on a hill and the light of the world that Jesus describes in Matthew 5:14.

I see the Holy Spirit working among us and through us in so many ways: hosting the community food pantry and looking for ways to grow that ministry, mentoring young people and teaching classes, visiting shut-ins, a Christmas gift project supporting a family devastated by fire, the annual Germanfest which supports those in need in our community, a sincere commitment to our synod and the churchwide organization, seminary leadership gifts, musical offerings, acolytes and volunteer assisting ministers, members of council and of committees... The list is long, and I bet we can do even more in the years to come!

As a parish, we celebrate the sacraments regularly. Our weekly partaking of Holy Communion is precious as we find our faith nourished in community around the Lord's Table. We have a baptism scheduled for January and I so look forward to those sacramental promises exchanged between God and our families in Christ.

The incarnate Word of God is our hope and stay, and blessings are found in the proclamation of that Word. The Word changes us in powerful ways, so let us recommit ourselves to regular contact with that Word through Bible reading, weekly worship, giving of resources, small group studies, true repentance, and grateful reception of God's grace-filled love and forgiveness.

So, if anyone is in Christ, there is a new creation; everything old has passed away; see, everything has become new! [2 Cor 5:17]

Even though the "old" is behind us, we remember with gratitude how our past has been blessed and guided by the hand of God, we trust God's promise of reconciliation, and we look forward to all that God will do as we travel a new path together in mission.
