It is time for your congregation's annual meeting! This is a great opportunity to reflect on the past year of faithful ministry. Now is the time to ask the BIG questions! How were we faithful in ministry? How were we faithful in participating in God's simple mission to love our neighbor? Now is the time to celebrate how God's Spirit has inspired your ministry! Give thanks to God and celebrate for the good that your congregation has accomplished!

Now is also the time to tell the truth about your ministry. How has your congregation fallen short and not been faithful to God's will? Lacked energy, a sense of purpose, or mission? PASTOR'S REPORT – 2024

Grace to you and peace from God our Father and our Lord Jesus Christ.

I am so grateful to have been serving as your pastor for a whole year! Experiencing the entire season of the church year alongside you has been a complete joy!

We have been blessed by increasing numbers of Sunday worship attendees, praise worship, healing services, beautiful banners and sanctuary decorations in every season, soloists, choirs, and faithful organists. Through volunteer ushers, assisting ministers, and acolytes, we continue to enhance the worship experience for all. We experimented with outdoor worship in our green space and will continue to tweak that program. Maybe I won't fall off my rock in 2024!

In 2023, I was privileged to participate with you in Germanfest. It's a good thing I like the smell of sauerkraut because that smell l-i-n-g-e-r-s. The money raised from the hard work of our volunteers will go toward making easier the lives of folks in our community. We also hosted the living nativity during Christmas in the Park and distributed handmade hats and mittens during that event and the Trunk-R-Treat event.

As a parish, we are grounded in the love of God in Christ Jesus, and we are given the power to show that love in action by the Holy Spirit. Our weekly celebration of the Lord's Supper—open to all, with no strings attached—nourishes us for that service. We have grieved the loss of several of our beloved members, but we are reminded that our grief will one day be buried in joy, and the baptisms we have celebrated this past year continue to remind us that we are children of The Most High God, chosen to advance God's mission of compassion, generosity, and mercy.

In the coming year, you will be challenged to think about stewardship. Financially, yes. But also in these ways:

Are we stewarding the promises of our baptism? Are we following through with those to whom we made promises? Are we asking the Holy Spirit to make our own spiritual life richer through bible study and prayer and worship?

Are we stewarding the opportunities we have working with our younger members? Have you thought about how you might be part of working with this group? Have we committed to support bible camp? VBS? Outings? Synod and national gatherings?

God's good work - although happening in the here and now - will not be complete until the day that Jesus Christ returns in judgment. AGENDA: Council's recommendation to the congregation for the future of the Cathy Belgea Zuelke gift of land.

New Business: Council recommendations - Upon mutual agreement with St. Joseph Catholic Church, and after much research, discussion, and prayer, the Council recommends that the 103.75 acres if vacant land in the Town of Cleveland, Marathon County, which is currently deeded to Zion Lutheran Church and St. Joseph Catholic Church per Cathy Belgea Zuelke's real estate bequest be sold with the proceeds divided equally between the two parishes.

M:Terry Schoenherr, To accept the Council's recommendations. S: Nicole Curtis

Christina Stroetz – What is the advantage to sell vs keeping land for rental income? Dan shared costs vs income with rental income and expense vs sale of land and investing money in CD. Terry Schoenherr – Increase in crop land sale value - \$6,500 - \$7,000/per acre. \$4,000 per acre was a low estimate used for purposes of comparison. Wesley Manecke – Has St Joseph had same congregational meeting? What is the minimum bid amount for the sale? Legal Fees? Advertising?

St Joseph's Catholic Church does not have to have the same meeting with the Diocese but the have also agreed to the sale of the land. Minimum has not yet been determined. Auction or realtor would be 6% commission. Advertising would be by the Auctioneer or Realtor.

PRESIDENT'S REPORT – 2023

Where did 2023 go? It seems like just last month we were doing the annual meeting. Things are back in full swing at Zion with J-team, Little Lutherans, and Confirmation groups all busy with activities.

Thank you to all parents for your commitment to your child's Christian education and the development of their faith. So wonderful to see them share their faith and love of Christ. It brings back memories of when I was that age. Developing that faith is so important, they are the church's future.

I am hoping you have noticed some of the changes that have been made to the church over the last year. Replacement of the sanctuary carpet and adding WIFI throughout the entire building are just a couple of things. Over the next couple of months, you will be seeing upgrades to some of the media we use in our services with improvements to the sound and picture quality. We will be changing from the projected images (announcements, hymns, etc.) onto the screen to mounted monitors. As a council, we are looking forward to the discussion and guidance you, as a congregation, will give your council.

As your council, we are trying to improve the communication and share more information with you the congregation. As always, if you have questions or concerns about things going on at Zion, please catch any member of council and we will do our best to answer them. I encourage each of you to continue to support Zion with both your time and financial giving.

WE are all very busy with jobs, family, and other commitments, but if each of us takes on just a little, it will not be too much for any person. Please consider increasing what you put in the offering plate by the amount and frequency. As in your household, the church's expenses continue to increase. In that regard, the council has decided to change the offering envelopes to help reduce cost. We will be ordering generic envelopes and distributing them to those who want to use them. I also ask you to consider using Simply Giving, which is the electronic transfer format for giving. This allows you to set the amount you choose to give to church and when. This gives Zion a more consistent flow of income. Since we are all so busy, there is no need to play catch-up if you miss a Sunday or two.

As a closing thought, I want to thank those members of your council whose terms of service are up. They would be Amy Cournoyer (6 years), Marge Redetzke (6 years), Ray White (3 years) and our youth representative, Casey Dasler. FAITH FORMATION 2023

The 2023 Faith Formation team was chaired by Ray White and included group members Kathy Ballerstein, Casey Dasler, Jasmine Grell, Janet Schoenherr, and Wendy Spaeth. Events coordinated by our team this year included: First Communion Sunday, Affirmation of Baptism, Senior Recognition Sunday, Kids Leading Worship Service, Bible Sunday and the Live Nativity.

Little Lutherans and JTeam started the fall of 2023 with 27 children attending bi-monthly Wednesday meetings. This year's curriculum was Essential Stories of the Bible led by the teaching staff that included; Jill Dasler, Sharla Dreiksen, Darla Leick, Brenda Huther, Janet Schoenherr and Pastor Amy Heinz. Additional volunteers helping with the program were Wendy Grell, Tom and Nancy Schoenherr.

The Christmas program theme was Jesse's Tree and was held during the December 17th morning service.

The 7th-9th grade confirmation program was reorganized by Pastor Amy Heinz. There are 12 students participating in that program with classes led by Pastor Amy as well as members of the congregation.

The 10th grade Disciples for Christ program included 7 students and their 7 mentors. Classes were led by Pastor Amy Heinz, with assistance from Jill Dasler and Darla Leick. Disciples for Christ meets monthly for a fellowship meal and topical discussion.

Vacation Bible School was held at Zion in July with the theme *Interstellar*. We again partnered with the Mill Church and provided meals, bible stories, music, games and crafts for the 4th-6th graders exploring their faith through the study of our galaxy and God's word.

2023 completed the 10th year of fundraising through the RaiseRight Program (formerly known as Scrip Program). A percent of each gift card is retained by Zion to help with Travel expenses for Youth Faith Formation activities such as National Youth Gatherings, mission trips, and camp experiences. The percent varies by company/retailer–from 2% to 12% or more.

We keep many local business RaiseRight cards in stock and are able to order a wide variety of retailers and restaurants. Nearly everywhere you shop and eat out has cards available.
